## Membership Rules

### *Approval*

The Club reserves the right to refuse or decline any application for Membership without reason or explanation.

### *Renewals*

Are due by the 30<sup>th</sup> June of each year. If you join the Club during the months of May or June, your membership will be rolled over for the next year.

### *Bowling Membership Applications*

New applications for Full Bowling Membership must have undertaken and met the required coaching standards to be eligible for weekly competitions.

\*Intro to Bowling Membership conditions: Valid for only 3 months from joining date. Valid for bowling days Monday and Wednesday only. After 3 months, Intro to Bowling Membership is no longer valid and will revert to a Social Membership or the Member has the option to pay the difference to become a Full Bowling Member.

\*Dual Bowling Membership conditions: Must be a current Full Bowling Member with the Men's Royal NSW Bowling Association, registered by another Bowling Club. Dual Bowling Members are not entitled to the same rights as a Full Bowling Membership which are outlined in the Club's constitution.

### *Club Dress Rules*

Not permitted at any time: Short shorts, training apparel, leotards, offense t-shirts, bare feet, baseball caps, swimwear, bike shorts, men's headwear and men's singlet's.

Not Permitted after 7pm:

Dirty or greasy overalls, torn or untidy tracksuits, torn or dirty joggers and any type of thongs.

Management decision shall be final in all matters relating to dress and behaviour.

### *Behaviour and Language*

Objectionable and obscene behavior or language will not be tolerated at any time in the Club's premises or in the Club's car park.

No person shall while in the Club's premises, behave in a manner dangerous to the public and to other patrons of the Club.

Smoking is not permitted in the Club. Smoking terraces are provided for smoking.

### *Offences*

If any member should fail to comply with the Club's Constitution or the By-Laws or membership rules or should cause offence to any member or members of the Club or behave in a manner prejudicial to the good order or the Club or the comfort or welfare of any member or members, they may be requested in writing to appear before a discipline meeting of the Board of Directors.

### *Membership Identification*

Members must produce current Asquith Bowling & Recreation Club Ltd membership identification upon request

- (i) To reception staff or security on each entry to Club premises; and
- (ii) On demand when so requested by any Manager, or Duty Manager, or staff member, or security
